7.1 Executive Summary: Office of International Education (OIE)

Narrative for SACS 2007

The Office of International Education (OIE) was established in 2003 and is supported through the Office of the Executive Vice President and Provost, supervised by the Associate Provost, Dr. Robert Nelsen, and directed by Dr. Rodolfo Hernandez Guerrero. The OIE mission is to support the teaching, research, and outreach missions of The University of Texas at Dallas by offering comprehensive, flexible coordination of international education opportunities to faculty and students. The Office seeks to be a resource on campus to foster international learning opportunities to educate and prepare individuals with skills necessary to function in a global environment.

After two years of the new OIE administration, the OIE team has overcome the profound discomfort was found among students and faculty regarding OIE services and a lack of communication between this office and other UTD administrative and academic units. Since September 2005, meetings have been conducted with UTD leaders, administrators, faculty, and especially students to discuss their experiences and identify the most optimal and efficient way to meet the OIE mission. These meetings haven been, and will continue to be, instrumental in incorporating perceptions, suggestions, and criticism in a continuous improvement process for OIE. To date, the result has been a redesign of OIE operations, enhancing a higher level of inclusiveness, visibility, and quality services.

During the academic year 2006-07, the results were beyond the criteria for success. The number of participating students in international programs and participating in "pre departure orientation sessions" increased by 61.53% and 164%, respectively; the number of students participating in the Study Abroad fairs increased by 230%; two Passport Fest were organized with the support of the U.S. Postal Services, encouraging community participation and collecting thirty one (31) passport applications; "research" was incorporated into the OIE portfolio of international mobility, especially for graduate students; the number of formal international collaborations increased

by 52%, OIE participated in related accredited associations conferences such as AMPEI, NAFSA, AIEA; several meetings were pursued with academic and administrative units to simplify and homogenize OIE protocols, including 22 changes and innovations for the protocol; OIE hosted fifty nine (59) guests that visited UTD to promote study abroad programs, exchange mobility, follow up collaborations, learn from UTD infraestructure, sign instruments of collaboration, research, studies; OIE moved to its new office, JO 5.504, which was designed to enhance a friendly and student oriented environment; 100% of OIE evaluation surveys indicated that the application process was excellent or fair and that students were satisfied with their program of choice; OIE web page was continuously edited and updated to offer clear, simple, consistent information to UTD community, especially students.

In order to expand the scope of OIE, since September 2005 we complemented study abroad programs with the design and implementation of international exchange programs. This new venue of international mobility has become a more accessible mechanism of mobility for our students since tuition is waived on a reciprocal basis. Also, students may have a deeper cultural and linguistic immersion by being guests of one of our international counterparts rather than traveling and pursuing study programs with other U.S. nationals. During the academic year 2005-06, UTD has signed exchange programs with Kyungpook National University, Korea, University of Kaiserslautern, Germany, City University of Hong Kong, Fudan University, China, Polytechnic University of Cataluna, Spain; and Sungkyunkwan University, Korea. In addition the exchange program agreement with the School of Physics and Astronomy at the University of St. Andrews, Scotland was renewed. During the 2006-07 academic year, UTD OIE formalized collaborations with two study abroad providers, Study Abroad Italy and Knowledge Exchange Institute, and with two exchange counterparts, University of Orleans, France, and the Technion Institute of Technology, Israel, amplifying the OIE portfolio for student mobility. In addition, UTD OIE re designed and signed the exchange program agreement with the University of Marburg, Germany, to comply with UT and UTD guidelines. Other international counterparts that formalized their collaboration with UTD during this academic year were Hayang University, Korea, L.N. Gumilyov Eurosian National University, Republic of Kazakhastan, Tyndall National Institute, Israel, Moscow State Institute of Steel and Alloys, Russia, The Federal State Unitary Enterprise State Scientific Research and Design Institute for Rare Metals Industry "GIREDMET," Russia; University of Sonora, Mexico, and Consortium of Semiconductor Advanced Research (COSAR). Also the UTD - Mexican Council of Science and Technology (CONACyT) collaboration was renewed during this year.

Future

Despite the short existence of the OIE, its strategy is constantly evolving to meet the expectations of our growing student population and to educate our UTD community about international education. Several projects will be designed and implemented within the next academic years (2007-2008). The OIE will:

- 1) Continue meeting UTD academic and administrative units to ensure and enhance the consistency and clarity of OIE protocols.
- 2) Create electronic surveys to measure student satisfaction with OIE services;
- 3) Continue identifying and formalizing new international collaborations, especially those which expand the portfolio of student mobility.
- 4) Continue identifying mechanisms to better facilitate awareness of international programs across campus.
- 5) Continue training OIE staff to effectively advise our students about international education.
- **7.2 Top 3 Program/Unit Accomplishments:** 1) Updating and keeping simple and consistent OIE protocols.
 - 2) One more new type of international mobility, research.
 - 3) Expanding the portfolio of international mobility for students.

7.3 Research Activities or Publications:

Offering international educational opportunities, including research, study abroad, exchange programs, independent studies, internships, and customized programs to enrich the UTD academic and research curriculum.

7.4 Instructional/Training Activities (presented or received): UTD OIE participated in the annual conferences of the Association of International Educators (NAFSA), Mexican Association of International Education (AMPEI), Association of International Education Administrators (AIEA). In addition, OIE participated in the NAFSA North Texas annual conference.

OIE representatives attended relevant sessions to learn from other institution representatives and met colleagues to share learning experiences. In addition, Rodolfo Hernandez attended two workshops: (1) "Chief International Education Administration 101 (CIEA 101)" and (2) "Tabletop Exercise for Pandemic Influenza Preparedness" at the AIEA and NAFSA conferences, respectively, and presented "the U.S. - Mexico Relationship, a Learning and Understanding Process: the Case of The University of Texas at Dallas (UTD)" at the AMPEI conference.

OIE offered two workshops to UTD faculty and staff about international education and the importance of the institutional protocol satisfaction for international mobility.
