President

Administrative and Professional - David E. Daniel -

Function:

The President is the chief executive officer of the institution and exercises broad delegated authority for campus administration. Responsible to the Board of Regents through the Chancellor for the operation and management of the university and for the execution of Board directives, the President serves as the primary spokesperson and leader for the university and spearheads efforts for strategic planning, continuous growth, advancement, and improvement across the campus community. The President provides close supervision and oversight to the executive staff, has primary responsibility for the compliance with intercollegiate athletics rules and regulations, and takes an active, if not lead, role in fund development and campaigns.

Scope:

In line with Series 20201 of the Rules and Regulations of the Board of Regents, the President shall

- develop and administer plans and policies for the program, organization and operation of the institution;
- interpret System policy to the staff, and interpret the institution's programs and needs to the System Administration and the public;
- develop and administer policies relating to students, and where applicable to the proper management of services to patients;
- recommend appropriate operating budgets and supervise expenditures under approved budgets;
- nominate all members of the faculty and staff, maintain efficient personnel programs, and recommend staff members for promotion, retention, or dismissal for cause;
- ensure efficient management of business affairs and physical property; recommend additions and alterations to the physical plant;
- serve as presiding officer at official meetings of the faculty and staff of the institution, and as ex officio member of each college or school faculty within the institution;
- appoint or establish procedures for the appointment of all faculty, staff, and student committees;
- cause to be prepared and submitted to the appropriate Executive Vice Chancellor and the Vice Chancellor and General Counsel for approval, the rules and regulations for the governance of the institution and any related amendments; such rules and regulations shall constitute the Handbook of Operating Procedures for the institution; any such rule or regulation in conflict with any rule or regulation in the Regents' Rules and Regulations is null and void and has no effect;
- assume initiative in developing long-range plans for the program and physical facilities of the institution;

- assume active leadership in developing private fund support for the institution in accordance with policies and procedures established in the Regents' Rules and Regulations;
- develop and implement plans and policies to ensure that the institution remains in compliance with any accreditation requirements appropriate to the institution or its programs.

Supervision:

The President reports to the Executive Chancellor for Academic Affairs, the Chancellor, and the Board of Regents of The University of Texas System. The President provides direct supervision to the executive staff of vice presidents and executive directors and assumes responsibility for the supervision of all faculty and staff through his delegated subordinates.

Education:

An earned doctorate from an accredited university or other applicable experience in higher education is required.

Experience:

The President shall have sufficient experience in leadership in or out of higher education so as to enable the incumbent to lead a diverse population toward continuous improvement and the pursuit of excellence in education and research.
