Summary

This CV provides a record of academic appointments, published scholarship, teaching, and university service spanning almost 20 years. My accomplishments related to administration include:

Administrative and Teaching Experience

My record of academic appointments reflects a depth and breadth of experience, both in terms of the skills I have developed as an administrator and diversity of communication and rhetoric courses I have taught at both the undergraduate and graduate levels. As Director of Rhetoric at UTD, for example, I have overseen the first-year writing program at a time of unprecedented growth in enrollment. The enrollment stood at approximately 14,000 students when I began in 2006, but as of Fall 2014, the enrollment has reached almost 23,000. This increase in enrollment means that I have supervised that many more students and instructors of our first-year writing course, RHET 1302. In collaboration with other instructors and administrators, I have developed successful methods of programmatic assessment as well as initiatives for the training of instructors. As an instructor myself, I have created and taught several advanced communication and rhetoric courses, including *Rhetorical Criticism*, *Rhetoric of Law and Policy*, *Digital and Visual Rhetorics*, *Public and Professional Speaking for Business*, *Communication Technology and Media Through Time*, and *Introduction to Computer-Mediated Communication*.

Published Scholarship

My record of published scholarship reflects original contributions in rhetorical theory and history, pedagogy for both written and spoken communication, and professional and technical communication. My work in the rhetoric of law, for instance, has attempted to revive interest in James Boyd White, a literary critic and legal scholar who began the "law and literature" movement while my studies of the rhetoric of William H. Parker, Chief of the Los Angeles Police Department from 1950 until 1966, coincide with my scholarly interest in how attorneys, judges, and persons in positions of authority make legal arguments outside the courtroom walls. Furthermore, scholars have given Parker and, more specifically, Parker's writings and speeches little attention, so I have brought to bear analyses of some little known and/or talked about artifacts. With regard to communication pedagogy, I have co-authored *Communication in a Civil Society* (Pearson Publishing), a textbook for introductory communication courses normally taught at the freshman or sophomore level. Currently, I am also writing a chapter for inclusion in an anthology titled *Communication in Emerging Media: What's Trending Now?* (Kendall-Hunt Publishing, 2015). My chapter will address three cases of "Global Crisis Communication."
