Welding Operation Guidelines

- 30' Radius (clear of any combustible material)
- Wind speed must be under 20 MPH (Maximum)
- Relative Humidity must be above 25%
- Mandatory fire guard watching with pressurized water extinguishers on site
- All persons welding outdoors must call EH&S (x4111) prior to work commencing. Undocumented welding will be considered in violation of the burn ban and subject to a fine and written documentation.



Outdoor Cooking Guidelines

All cooking devices that are propane or natural gas must have a complete enclosure.

Wood or charcoal must have full enclosure at all times, including all areas around the cooking device must be clear of combustible debris for a 5' radius
