# **Advising BBS**

The School of Behavioral and Brain Sciences provides very extensive community service through numerous service programs of its Callier Center and Center for Brain Health, as well as collaborative efforts of various faculty. The Callier Center offered over 25 different clinical service programs generating over 40,000 patient contacts during 2006. Examples are its programs with such clinical populations as hearing impaired individuals across the age spectrum, language disorders, speech problems and autistic spectrum disorders. Similarly the Center for Brain Health offers service programs in Alzheimer's disease and Brain-injury in children. The School has extensive programs with numerous school districts providing educational programs for all hearing-impaired preschoolers in the Dallas Independent School District and audiological consultation with the Plano School District. Individual faculty in our neuroscience programs have also provided seminars for Plano and Richardson Schools in the area of brain research. The Center for Brain Health hosts an annual public lecture series on aspects of brain research and the Callier Center offered two Bruton Conferences in 2006 primarily for professionals in the field of communication disorders. Callier audiologists also participated in outreach programs for hearing assessments in Panama and Mozambique.

## **Advising ECS**

# **Advising General Studies**

We have always been willing to advise students at the community colleges who wish to transfer to UTD. Until recently, this has not been a policy at UTD. Many students were turned away if they were not registered students. Also, we always offer friendly and courteous service to phone calls which reach us because we are General Studies, and they have "general" questions, which have nothing to do with our school. Back, in 1994, we began the practice of phoning students who attended one semester and then did not attend the second one. We tried to find out, in a non-threatening manner, why they did not return. Most were surprised and pleased that we had noticed their absence. Many promised to return. The main reasons for "stopping out" were financial and/or family/work issues.

# **Audit**

Work with Dallas Chapter of the Institute of Internal Auditors and Association of College and University Auditors on programs, conferences, and Board of Governors. Serving in this way helps benefit others within the State of Texas as well as globally.

Worked with graduate students in the School of Management on audits and provided them real-world audit experience.

#### Library

The Library provides support to the community through a number of initiatives. Through the use of TexShare, a state-wide program administered by the Texas State Library and Archives Commission, members of the community can borrow items from the collection. The Library also enables walk-in customers access to nearly all electronic resources.

As a government depository, McDermott Library selects and organizes resources produced by the federal and state agencies. These resources are selected to support the interests of the campus and the community.

The Libraries provide outreach to the community by making all local librarians aware of the resources available and initiate tours of the collections for those individuals. In addition, the Library provides tours of its collections and an introduction to its services for campus visitors.

Finally, the Libraries provide a number of special programs including lectures and exhibits as related to collections or events held on campus. These programs include presentations by librarians and noted scholars.

# **McDermott Scholar Program**

McDermott Scholars have dedicated thousands of volunteer hours to community service projects in Dallas and elsewhere. Some examples:

- Dallas Independent School District Elementary Schools: Hexter, Kramer, Marcus, and Preston Hollow
- Habitat for Humanity and its home-rehab analog, Hearts and Hammers
- Local hospitals, such as Parkland, Scottish Rite, and Baylor
- Adult-ESL tutoring with Project LIFT (Literacy Instruction for Texas)
- Translation services in legal and medical clinics
- Volunteer docents at the Dallas Museum of Art
- School supply drives, both locally and for impoverished rural Mexican schools

## **Enrollment Services**

Staff members participated in the annual Komen Race for the Cure Marathon, served on the Dallas, Texas Scholarship Committees of the Asian Chamber of Commerce, the Black Chamber of Commerce, the Hispanic Chamber of Commerce and also provided Christmas gifts for the Salvation Army Angel Tree. Three staff members are Leadership Level members of the State Employees Charitable Contribution group.

#### **Provost Office**

The Provost supported the student publication A Modest Proposal and continued his intense interaction with the McDermott Scholars Program. Dr. Wildenthal continued to work closely with the McDermott Foundation on a number of initiatives, including the campus beautification planning and the promotion of the Dallas Zoo.

#### **Public Affairs**

Public Affairs representatives participated in a variety of community groups and organizations. Leadership also worked to enhance relationships with area elected and public officials to communicate the activities and interests of UT Dallas.

The Office of Public Affairs coordinated the UTD Service & Civic Participation initiative, which encourages UTD students, staff and faculty to create a login to track volunteer activities in the community. Public Affairs hosted joint registration fairs for this

initiative with UTD's service learning staff to ensure that the University community is aware of public service opportunities and awards for service.

## **Staff Council**

Provide free flu shots to employees and provide staff scholarships to assist employees with higher education costs.

## **US Mexico**

Active participation in community events to enhance the analysis and understanding of the U.S.-Mexico relationship.
