Course Pre-requisites, Co-requisites, and/or Other Restrictions

A knowledge of College Algebra is required, MATH 1314 or equivalent. The course will begin with a review of some key topics.

Course Description

Techniques of mathematical analysis applicable to the social, behavioral and management sciences. Differential and integral calculus of one and many variables.

Student Learning Objectives/Outcomes

Students will be able to articulate the fundamental ideas and uses of differential and integral calculus as encountered in business studies; students will be able to apply Calculus to economic and business analysis and modeling; such as continuously compounded interest, depreciation, learning curves in market penetration, valuation of cash flows with interest or variability assumptions, elasticity, and optimization. Students will be able to articulate basic calculus techniques for functions of two variables.

Required Textbooks and Materials

Lial, Greenwell, Ritchey *Calculus with Applications*, Eighth Edition, Addison-Wesley.

There will be two exams and a comprehensive final exam. There will be **no** make-up or re-scheduling of an exam. Exam 1 on Feb. 6 and Exam 2 on Mar. 19 will be given during the first 75 minutes of class, after which lecture will continue. The final exam on May 7 will be divided into three sections. The first section is **required**; it will cover the material presented after Exam 2 and will count equal to a major exam. Two other sections are **optional**: they will cover the material of Exams 1 and 2, respectively. The score from the optional section will be used if it is **larger** than the score earned on Exams 1 and 2, respectively. Textbooks, notes, graphing calculators, etc. are **not** allowed on exams.

Homework will be collected at the beginning of each class and will be graded.

Grading Policy

The two exams and the required section of the final exam will each count 100 points. Exams 1 and 2 will each make up 30% of the grade, the combined homework grades will make up 5% of the grade, and the first section of the final exam will make up 35% of the grade. The term average will be converted into letter grades by the rule:

A 90-100; B 80-89; C 70-79; F 0-69. In graduate courses there is no D grade.

Course & Instructor Policies

Students are expected to attend all lectures and to avoid talking or interfering with the attention of others. All exams are closed-book and without notes. Students are expected to maintain silence and to avoid any observation of others ♦ f papers.

Email Use

Withdrawal from Class

The administration of this institution has set deadlines for withdrawal of any college-level courses. These dates and times are published in that semester's course catalog. Student Grievance Procedures

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the dean will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Copies of these rules and regulations are available to students in the Office of the Dean of Students, where staff members are available to assist students in interpreting the rules and regulations.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of **F**.

If you anticipate issues related to the format or requirements of this course, please meet with the Coordinator of Disability Services. Religious Holy Days

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
