Course Description

Students will participate in small group design projects that contribute to the overall design of a small satellite (CubeSat) system. The student groups will research, design and/or procure telemetry, guidance and control, power, and instrumentation systems. Subsequent courses will allow students to continue the project by building and testing the complete satellite system.

Student Learning Objectives/Outcomes

Through small group design and student interaction the design teams will learn to function as part of an overall design group to achieve a major design objective. Skills to be mastered include researching existing systems, designing new systems, presenting/sharing results with other design teams, and integrating subsystems into a larger project. Elements of orbital mechanics, radiation tolerance, communication systems, and hybrid electronic design will be mastered as milestones leading to the final design.

Required Textbooks and Materials

Handouts will be furnished by the instructor to augment web-based materials.

Suggested Course Materials

Assignments & Academic Calendar

Weekly reading, research, and design presentations will be assigned in class. Presentation of a final design document will comprise the semester-end deliverable.

Grading Policy

Grading will be based on weekly design presentations, feasibility of the final subsystem design, and team member assessments of student contributions to the overall project.

Course & Instructor Policies

There are no exams. Design milestones are assessed continuously throughout the semester, along with solutions to particular design problems encountered. 50% of the grade is based on the final design document, which is assessed for feasibility, cost, creativity, and ease of integration with other systems. A laboratory will be accessible to students to allow the use of state-of-the-art satellite orbital analysis tools, computer aided design packages, and reference materials.

Student Grievance Procedures

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the dean will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of **F**.

If you anticipate issues related to the format or requirements of this course, please meet with the Coordinator of Disability Services.
