**COURSE  
DESCRIPTION**

THE COURSE INTRODUCES BASIC CONCEPTS OF PROBABILITY AND STATISTICS AND EXAMINES A VARIETY OF PRACTICAL TOOLS, EMPHASIZING THE SETTING OF LIFE SCIENCES, SUCH AS HEALTH CARE DATA AND CLINICAL TRIALS. KEY TOPICS INCLUDE:  
*DESCRIPTIVE STATISTICS, COMMON PROBABILITY MODELS, ESTIMATION, HYPOTHESIS TESTING, NONPARAMETRIC MODELS, REGRESSION AND CORRELATION, DESIGN OF EXPERIMENT, AND ANALYSIS OF VARIANCE.*  
A WORKING KNOWLEDGE OF THE COMMONLY USED BASIC METHODS AND AN ABILITY TO FOLLOW TYPICAL STATISTICAL DISCUSSIONS FOUND IN THE LITERATURE WILL BE DEVELOPED. IN PARTICULAR, STUDENTS WILL BE ABLE TO:

1. RECOGNIZE THE REQUIRED STATISTICAL METHOD (CONFIDENCE INTERVAL / HYPOTHESIS TESTING) APPROPRIATE FOR STATISTICAL DECISIONS BASED ON THE NATURE OF THE PROBLEM (ONE-SAMPLE, TWO-SAMPLE INFERENCES, ONE-TAILED OR DOUBLE-TAILED ALTERNATIVES, ETC.)
2. APPLY STATISTICAL PROCEDURES TO DATA AND INTERPRET THE RESULTS OBTAINED, USING RELEVANT SAMPLING DISTRIBUTIONS (BINOMIAL, NORMAL, T-DISTRIBUTION, CHI-SQUARE, F-DISTRIBUTION, ETC.)
3. DEVELOP AND FIT LINEAR REGRESSION MODELS TO CORRELATED VARIABLES, AND EVALUATE PERFORMANCE AND ACCURACY OF THE MODEL.

<p><b>Email Use</b></p>	<p>The University of Texas at Dallas recognizes the value and efficiency of communication between faculty/staff and students through electronic mail. <p><b>Student Grievance Procedures</b></p>	<p>Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's <i>Handbook of Operating Procedures</i>.</p> <p>In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not</p>

	<p>resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the dean will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.</p> <p>Copies of these rules and regulations are available to students in the Office of the Dean of Students, where staff members are available to assist students in interpreting the rules and regulations.</p>
<b>Incomplete Grades</b>	<p>As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of <b>F</b>.</p>
