Two semesters of Calculus (MATH 2417 and MATH 2419 or equivalent) and courses in Probability STAT 4351 and Statistics STAT 4352.

Course Description

The student will be introduced to useful frequency and severity models as well as to the steps involved in the modeling process and how to carry out these steps in solving business problems. Topics in loss distributions, modeling, estimation by simulation, aggregate risk models, survival models, stochastic processes and ruin models will be discussed both theoretically and via examples. Tools for the calibration and evaluation of the models are also discussed.

Student Learning Objectives/Outcomes

The student is expected to be familiar with survival, severity, frequency and aggregate models, and use statistical methods to estimate parameters of such models given sample data. The student is further expected to identify steps in the modeling process, understand the underlying assumptions implicit in each family of models, recognize which assumptions are applicable in a given business application, and appropriately adjust the models for impact of insurance coverage modifications.

This course is also a partial preparation for Exam 4/C of the SOA and the CAS.

Email Use

Incomplete Grade Policy
