General Course Information

Pre-requisites, Co-requisites, & other restrictions Must have a UTD computer account. At least two prior graduate courses in seismology, or written consent of the instructor

Course Description

This course is a survey of the theory, implementation, and applications of the major algorithms for the computation of synthetic seismograms. Topics include asymptotic ray theory, spectral and slowness methods, finite-differences, finite elements, pseudo-spectral methods, Kirchhoff, and boundary element methods. Special topics include visco-elasticity, scattering, and anisotropy.

Learning Outcomes

To have a firm theoretical and practical understanding of the main procedures for numerical simulation of seismic data. To be able to evaluate the strengths and weaknesses of alternative algorithms and thereby to choose an appropriate one for any particular data set or problem. To demonstrate these abilities by doing them in the term project.

TERM PROJECT

The term project is on any topic of your choice related to seismic modeling. It should involve the production and use of software for synthetic seismograms to solve a problem or investigate a phenomenon. It should demonstrate your understanding of the technique(s) you have chosen to use. THIS IS A TERM PROJECT, NOT A WEEKEND PROJECT; grading will reflect an assumption that three months work are involved. GPR modeling may be substituted

for seismic for those doing a GPR thesis or dissertation. If you are not sure whether what you want to do fits the requirements, check with the instructor before you start.

The format for the term project report is like a research paper (consult your favorite research journal for examples).
