Course Description

This is a project oriented class in which students will design, build, test, and or validate the performance of one or more spacecraft subsystems. The instructor will serve as the project manager, and students will work in small groups to accomplish specific objectives assigned throughout the semester. The beginning segment of the course involves lectures to prepare the class for the project – this includes overviews of the space environment, plasma physics, orbit scenarios, instrumentation, and the mission objectives. After this introductory material is absorbed students will begin group work on their specific assignments.

Student Learning Objectives/Outcomes

Students will learn basic orbital mechanics, the physics of the near-Earth space environment, and satellite subsystem details commensurate with the level of the design objectives.

Required Textbooks and Materials

The course is taught from handouts, as required. No textbook is required, but several texts and software/hardware documentation and tutorials will be used throughout the semester.

Assignments & Academic Calendar

Assignments will be made throughout the semester. These will generally take the form of oral and written presentations and/or laboratory system demonstrations.

Grading Policy

Grades will be calculated and assigned based on the following guidelines:

- 30% diagnostic exam (mid semester)*
 - 30% cumulative project reports and demonstrations*
 - 30% final project design report (written and oral)*
 - 10% instructor discretion*

Student Grievance Procedures

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the

respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of **F**.

If you anticipate issues related to the format or requirements of this course, please meet with the Coordinator of Disability Services.
