Course Description

GEOS 5380 Seismic Interpretation (3 semester hours) Seismic reflection profiling as it is used to map the distribution of sedimentary layers and faults in the subsurface. Special emphasis is given to applications in hydrocarbon exploration. Extensive use is made of software processing packages.

Course will provide students with skills to interpret seismic data needed as a geoscientist in an oil and gas company.
