### General Course Information

**Pre-requisites, Co-requisites, & other restrictions** Prerequisites: CHEM 2125 and CHEM 3472 or consent of instructor

#### Course Description

Careful handling practices and controlled variation of reaction parameters to obtain high yield syntheses. Use of standard separation techniques and spectrophotometric methods to identify reaction products and assess their purity.

**CHEM 3471 Advanced Chemical Synthesis Laboratory (4 semester hours)**. Careful handling practices and controlled variation of reaction parameters to obtain high yield syntheses. Use of standard separation techniques and spectrophotometric methods to identify reaction products and assess their purity.

#### Learning Outcomes

*Course Objectives:* This course is designed to prepare students for chemical research by providing instruction in methods of chemical synthesis, isolation, purification and characterization which includes both physical and spectroscopic techniques. The students will also learn how to keep a research notebook with an emphasis on communicating procedures, observations and data in such a way that results could be duplicated using only the notebook.

#### *Expected Outcomes*

1. Students will plan and conduct a chemical synthesis
2. Students will be able to explain and evaluate modern purification methods
3. Students will use instrumentation including NMR, FT-IR, UV-Vis, XRD etc
4. Students will document data and observations in lab reports
