# **Physics 4301 Quantum Mechanics**

**Course Pre-requisites:** PHYS 3311 and PHYS 3352 and either MATH 2333 or MATH 2418.

**Course Description:** Fundamental principles of quantum theory with application to one and three dimensional systems under various potentials; free particle; bound particle; harmonic oscillator, angular momentum, hydrogen atom, exchange symmetry, and perturbation theory.

**Student Learning Objectives/Outcomes:** In this course students learn the basis of quantum physics. They will develop their mathematical skills to calculate the electronic structure of simple atoms and molecules.

**Textbooks:** Introduction to Quantum Mechanics, 2nd Edition by David Griffith, Chapters 1-4, a brief review of Appenix A, and parts of Chapters 5 and 6.

# Email Use

## Withdrawal from Class

#### **Student Grievance Procedures**

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. #### **Incomplete Grade Policy**

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade

A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
