Course Description

Notions of immortality and concepts of eternity-the struggle to understand human existence and the physical world. The geocentric universe-a Graeco-Christian compromise. The Renaissance and the slow acceptance of the Copernican universe. James Hutton's Earth machine and William Smith's strata-the progeny of the Enlightenment and the Industrial Revolution. Biostratigraphy, the great stratigraphers and Victorian reaction to the realization of Earth's antiquity. Lord Kelvin's arguments for a young Earth. Discovery of radioactivity and the refutation of Kelvin. Patterson and the age of the solar system. Modern rock dating techniques. A walk through geologic time.

Student Learning Objectives/Outcomes

After completing this course, students will be able to:

- Explain how the Ancient World's concept of an eternal earth changed through religious beliefs into the medieval one in which the earth would last only 6000 years.
 - Recount how the English renaissance was marked by scientific rather than artistic accomplishments and culminated with Newton's establishment of the heliocentric solar system.
 - Recount how, despite the exposition of stratigraphic principles by Steno in 1669, 18th century geologists attempted to explain sedimentary rocks in terms of Noah's flood.
 - Explain how the deism of the Enlightenment and the industrial revolution's need for raw materials led to James Hutton's irrefutable demonstration that the earth was indeterminably old.
 - Recount the growth of geology as a science in the 19th century and its cultural impact as recorded in Victorian literature.
 - Explain how the discovery of radioactivity led to an absolute means of measuring geologic time.
 - Describe the principles and methods involved in measuring the ages of rocks.
 - Recount the principal events that occurred over the history of the earth.

Student Grievance Procedures

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the dean will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of **F**.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence; a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
