

Course Description: This honors readings course will involve a close reading of a select group of texts related to medicine, politics and philosophy.

Student Learning Objectives/Outcomes: Upon completing the class, students will be able to

- 1) Identify a number of different genres of literature related to the field of medicine.
- 2) Explain different ways in which historians have conceptualized the history of medicine as a profession.
- 3) Describe the role that microorganisms have played in human history and various social and political responses to disease in the delivery of medical care.
- 4) Describe the role that modern science and technology have played in redefining the practice of medicine over the past 300 years.
- 5) Identify the major philosophical, clinical, and practical problems facing medical practitioners in medicine in the 21st century as they attempt to empower patients in their own healthcare.

Grading Policy:

Students are expected to come to class prepared to discuss the material. In-class participation is worth 10% of the final grade.
