Course Pre-requisites, Co-requisites, and/or Other Restrictions

Pre-requisite: College algebra and Computer-Literate. Background in lower-division probability theory and lower-division computer programming is helpful.

Course Description

This course will cover some selected probabilistic approaches to natural language understanding with an emphasis upon the use of MATLAB as a software tool.

Laboratory Notebook

Each student is required to maintain and organize a laboratory notebook which consists of seven sections (one section for each laboratory assignment). The laboratory notebook should be submitted with your midterm in the middle of the semester and then submitted again with your final at the end of the semester. This class is not difficult if you keep up with the material

but it is very easy to get far behind in this class since we cover a lot of topics. A copy of your presentation and a xerox copy of the article you are presenting for your presentation should be included in an eighth section. Students with advanced backgrounds in mathematics and engineering have an option of pursuing alternative extra credit projects to substitute for one or more homework assignments. These alternative extra credit projects should be included in the lab notebook. The lab notebook contents will be graded twice (once for completeness at the midterm and once for completeness at the final exam). *The lab notebook must be neatly organized or it will not be accepted for grading!*

Probabilistic Language Understanding Application: <u>Presentation</u> and <u>Final Paper</u>

Each student will be required to present at the end of the course both a *final paper* and a 20 minute *presentation* which describes how they solved a particular problem in natural language understanding using probability theory. Students may download software off the web or write their own software using MATLAB or a computer language approved by the instructor. The presentation must be presented in powerpoint format and should devote equal amounts of time of approximately 5 minutes to each of the following 4 topics: (1) INTRODUCTION (what is the research problem and why is it important), (2) METHOD (what neural network was used and how was its performance evaluated), (3) RESULTS (what did you find out), and (4) DISCUSSION (how do the results in this study impact the relevant field of research). There will be a brief discussion period following each presentation. The Final Paper should be handed into the instructor on the day of the Final Exam and

This course will use the resources of turnitin.com, which searches the web for possible plagiarism and is over 90% effective.

Email Use

Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. Essentially, the law requires that colleges and universities make those reasonable adjustments necessary to eliminate discrimination on the basis of disability. Religious Holy Days

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
