General Course Information

Pre-requisites, Co-requisites, & other restrictions Prior functionality in C++ or Fortran is required; a prior graduate course in seismology, signal processing and numerical analysis is desirable. Consult with the instructor before registering if in doubt.
Principles of Parallel Computation with applications to seismic wavefield transforms. Writing and debugging parallel code, characterization of machine performance, fast Fourier transforms, Radon transforms, the Fourier central slice theorem, solution of matrix and wave equations.

Course Description

Emphasis is on hands-on experience in MPI (Message Passing Interface) programming in a cluster computing environment.

Assignments involve writing, testing, and documentation of original computer programs by the students.

Theoretical and practical aspects of computation of the seismic wavefield transformations that are the basis of seismic data processing, with emphasis in implementation in a parallel computational environment. To be able to think and function in a parallel computing environment. To understand, and be able to use, the relationships between the main transform domains in design of processing streams.

Learning Outcomes

To be able to evaluate the strengths and weaknesses of alternative procedures, both in the lecture material, and in the technical literature. To clearly and coherently communicate technical material, and their implications for solving geophysical problems. To demonstrate these abilities by using them in developing software for the assignments and in the assignment reports.

Student Grievance Procedures	<p>Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's <i>Handbook of Operating Procedures</i>.</p> <p>In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean.
