Course Description spectroscopic techniques, mass spectrometry, and microscopic and

Course Objectives:

The objective of this course is to introduce the graduate students to a range of analytical instrumental methods. The analytical techniques include qualitative optical spectroscopic methods (e.g. FTIR, ATR-FTIR, Raman spectroscopy, and powder X-ray diffraction), quantitative optical spectroscopic methods (e.g. AA, ICP-AES, ICP-MS, XRF, UV/Vis, Fluorescence Spectroscopy), mass spectrometry (e.g. EI-MS, CI-MS), and microscopic and surface analysis methods (e.g. STM, AFM, SEM, XPS).

Upon successful completion of this course, students will therefore:

- 1. Be able to explain and apply the theory and instrumentation of instrumental analysis methods.
- 2. Be able to search the chemical literature and synthesize and evaluate information from that research.

Student Grievance Procedures	Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's <i>Handbook of Operating Procedures</i> . In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. Religious Holy Days

The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
