### General Course Information

<b>Course Description</b>	Survey of inorganic chemistry with emphasis on the modern concepts and theories of inorganic chemistry, including electronic and geometric structure of inorganic compounds. Topics address contemporary physical and descriptive inorganic chemistry.
<b>Learning Outcomes</b>	<p><u>Objectives</u></p> <p>The goal of this course is to provide students with a thorough foundation in atomic structure, periodicity, bonding and symmetry with subsequent extension of these basic principles to acid/base, solid state and coordination chemistry. Students will develop an understanding of the elements and the ability to predict the structures, certain properties and reactivities of a range of representative ionic and covalent compounds.</p> <p><u>Expected Learning Outcomes</u></p> <p>Upon successful completion of this course, students will therefore:</p> <ol style="list-style-type: none"><li>1. be able to explain atomic structure and bonding using currently accepted theories.</li><li>2. be able to use group theory to describe molecular orbital diagrams and molecular properties.</li><li>3. be able to integrate knowledge of atomic structure with the structure and properties of ionic and molecular compounds.</li><li>4. be able to explain the history, bonding and properties of representative main group elements and coordination compounds.</li></ol>

Dates of assignments to be determined.</p> <p>(ii) <i>Midterm exams:</i> ALL 4 MIDTERM EXAMS MUST BE TAKEN, at the scheduled time and on the scheduled day. <b>There will be no makeup exams given.</b> If you have an <b>acceptable, documented reason</b> for missing an exam (e.g., documented illness, auto accident, participation in UTD-sponsored event, observance of religious holiday), you will be allowed to replace the missed exam with your score on the final. <b>Student Grievance Procedures</b>	<p>Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's <i>Handbook of Operating Procedures</i>.</p> <p>In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.</p> <p>If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee.
