Course Pre-requisites, Co-requisites, and/or Other Restrictions

Formal prerequisites for this course are MATH 2418 (Linear Algebra), CS 2315/CS 2336, and CS 3345. You should have some familiarity with basic linear algebra and geometry, and good working knowledge of C/C++ programming.

Course Description

This course gives a comprehensive overview of the field of computer graphics. It will cover the basic concepts, mathematical foundations, fundamental theory and algorithms, software techniques, hardware and system issues, and application examples of computer graphics. The main topics will center on modeling and rendering. If time permits, we shall give a brief overview of various advanced graphics research topics.

Student Learning Objectives/Outcomes

After successful completion of this course, the students will be able to:

- Explain general concepts related to 2D and 3D graphics
- Be familiar with mathematical tools for graphics algorithms and graphics hardware
- Understand the graphics pipeline, including transformation, projection, lighting, etc.
- Use OpenGL as a tool for creating graphic scenes
- Use texture mapping and environment mapping to improve quality of scenes
- Be well prepared for graduate research or work in computer graphics

Important: The dates in this schedule may change due to the class level. If the class needs more time and examples to understand a concept I will modify the schedule. If the class is ready to skip a chapter or go faster I will modify the schedule. Grading Policy

This course emphasizes a "hands-on" approach to both the better understanding of graphics theory/algorithms and the effective use of graphics techniques. Each student is required to complete assignments. The assignments involve both analytic problems as well as programming projects using parts of graphics packages. The programming projects will be done in C/C++ and OpenGL. You are expected to be a competent programmer in C/C++ in this course. All the problem sets, projects, and exams are mandatory. The final grade will be composed of the following three parts:

- Programming Assignments: 45%
 - Assignment 0 (0%): Preparing your programming environment.
 - Assignment 1 (15%): OpenGL Basics
 - Assignment 2 (15%): Shading and Rasterization
 - Assignment 3 (15%): Texture Mapping
- Midterm Exam: 20%
- Final Exam: 35%

Student Grievance Procedures

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the dean will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of **F**.

Essentially, the law requires that colleges and universities make those reasonable adjustments necessary to eliminate discrimination on the basis of disability. For example, it may be necessary to remove classroom prohibitions against tape recorders or animals (in the case of dog guides) for students who are blind. Occasionally an assignment requirement may be substituted (for example, a research paper versus an oral presentation for a student who is hearing impaired). Classes enrolled students with mobility impairments may have to be rescheduled in accessible facilities. The college or university may need to provide special services such as registration, note-taking, or mobility assistance.

It is the student's responsibility to notify his or her professors of the need for such an accommodation. Religious Holy Days

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
