### **Graduate Classes Taught**

*Econ 6306 Applied Econometrics.* This course, required for students in both the master’s program in Economics as well as various School of Management programs, is an accelerated introduction to econometrics. Topics include a review of the ordinary least squares basics, model specification and selection, GLS, maximum likelihood estimation, binary choice models, time series models, and simultaneous equation models. There is a heavy emphasis on using statistical software to estimate each model.

*EPPE 7318 Structural Equation and Multilevel (Hierarchical) Modeling.* This course is an introduction to structural equation modeling (SEM) and multilevel modeling (MLM). The course is in the curriculum of the doctoral programs in Economics and Political Economy and the masters programs in Applied Economics.

*OPRE 6301 Quantitative Methods for Business Decision Making.* This class provides a broad introduction to the principles and techniques of data analysis and statistical inference. The course is required in the accredited Global Executive MBA program and is taught primarily on-line.

*Political Economy (POEC) 5305 Microeconomics for Policy I.* This course develops the tools of economic analysis and demonstrates their uses for decision making and the evaluation of public policies. Required course for doctoral students in Political Economy, and masters students in Public Affairs and in Applied Sociology.

*Political Economy (POEC) 5313 Descriptive and Inferential Statistics.*  
This course provides a broad introduction to the principles and techniques of data

analysis and statistical inference. Required course for doctoral students in Political Economy, and masters students in Public Affairs, masters students in Applied Sociology, and masters students in geographic information systems.

*POEC/ECO 5314 Public Sector Economics.* This course examines the economic role of government in a mixed economy. The course is in the curriculum of the doctoral programs in Economics and Political Economy and the masters programs in Applied Economics and Public Administration.
