Student Learning Objectives

- Think critically about issues related to government and politics—analyze and appreciate historical trends in the development of government institutions (constitutions, branches of government, political parties, elections, etc.), and apply knowledge of government institutions and theoretical and scholarly approaches to understand government behavior and current events.
- Effectively communicate issues of societal and personal import with others- meaningfully and respectfully express your positions and ideas on political and social issues to fellow students, community members, public officials, and representatives.
- Engage academically and professionally with a sense of social responsibility- recognize that individual actions can have consequences for society just as government actions can have consequences for individuals, and engage with the world around you with awareness and empathy.

• Exercise personal responsibility in how government functions-understand how to effectively interact with government to achieve desired outcomes, and begin a lifetime of active engagement with your government.

- 1. Demonstrate an understanding of the influence founding principles have on today's political structure, including current political and policy debates.
- 2. Describe the ever-changing relationship between the federal government and state and local governments.
- 3. Explain how the executive, legislative, and judicial branches were designed to check and balance governmental power, and assess how they have worked in practice
- 4. Examine the evolving role of civil rights and civil liberties protections in U.S. law
- 5. Analyze issues, public policies, and political culture in the U.S. from an empirical (e.g., evidence-based) rather than opinionated frame.
- 6. Identify, describe, and analyze various mechanisms of citizen political involvement including public opinion, political parties, interest groups, and electoral processes.
- 7. Apply important theoretical and scholarly approaches to understanding American institutions' behavior, citizen involvement, and interactions between citizens and institutions of government.
- 8. Consider the above factors when designing, strategizing, and proposing workable policy solutions to complex governmental and societal problems facing America today

Homework - 40%

Homework is integrated into the textbook via TopHat and is completed by answering the questions embedded in the weekly readings in each chapter. For final assessment, students will be evaluated based on the 13 highest scored homework assignments. This means the lowest two homework grades will be dropped. This provides students the flexibility to miss up to two homework assignments without penalty. In order to receive full credit for the homework assignments, students must answer all of the questions in each chapter. The questions are worth one point each and evaluated equally on two factors: participation and correctness. Participation is whether you progressed through

the chapter and attempted each question. Correctness is whether you provided the right answer to the question. Below is a sample calculation for figuring out a grade on a homework assignment.

- Total number of questions in the chapter: 10
- Total number of questions attempted (participation): 10
- Total number of correct answers (correctness): 8
- Calculation: (10 * 0.5) + (8 * 0.5) = 9
- Assignment Score: 90%

2 Exams - 30% Each

Exams will be conducted online through TopHat; students are welcome to use course materials and notes. Exams will feature a variety of questions which test your recollection of topics and concepts covered in class along with your ability to critically analyze and apply those topics to the U.S. governmental system.

Exams 1 and 2 will be made available to students for 72 hours. Once you begin the exam, you will have 75 minutes to complete the exam. If you start the exam within 75 minutes of the due date and time, you will not be allotted extra time. The exams are online meaing students can select the location where they will complete the exam. Coordination or taking the exam as a group is prohibited.

Remember, all due date times are CT (Central Time).

- Test 1 will cover material from Modules 1 through 8.
- Test 2 will cover material from Modules 9 through 15.

Final Exam - Optional

Given that we have missed several classes, the Policy Paper has been removed as a major assignment from the course. It will be replaced with an optional Final Exam. The Final Exam will be comprehensive meaning it will cover content from Modules 1 through 15. If a student opts to take the Final Exam, your two highest exam scores will be used to calculate your final grade. If students are satisfied with their grade after Exam 2, they are not required to take the Final Exam.

Since it is being held during finals week, the final exam will only be available to students for approximately 12 hours on May 11. Once you begin the final exam, you will have 2 hours and 30 minutes to complete the exam. If you start the exam within two hours and 30 minutes of when it is due, you will not be allotted extra time.

Make-Up Exams

Exams will be take online using TopHat. Exams will take place when class is scheduled to meet on March 11 and May 4. Since the exams are online, students Students who miss exams due to a medical emergency, death in the family, or a university sponsored activity may be approved for a make-up exam. Students must reach out to the instructor and provide documentation to verify the event (e.g. doctor's note, note from university sponsored activity, etc.). Approval of make-up exams is at the instructor's discretion and must be completed within 1 week of the last day of the exam.

This course is meant to serve as an introductory survey of the U.S. Federal Government. Course material may cover topics that some considered to be controversial or provocative - the instructor will do their best to present this material in the context of the subject being discussed.
