Course Description

The aim of this course is to lay the foundations for good empirical research in the social sciences and to introduce students to the assumptions and logic underlying social research. Students are exposed to a variety of approaches to research design, develop their own research projects, and evaluate the products of empirical research.

Students learning objectives/outcomes

By the end of the course, you should be able to:

- a) plan a program of research, including the following steps:
 - formulating a research question,
 - developing the research theoretically,
 - integrating what is already known (the extant literature) and developing new hypotheses,
 - designing a study to test these hypotheses, and
 - designing data collection methods and measures that accurately reflect the study design and the theory; and
- b) critique research done by others, covering all five points above.

Course Requirements
