Course Description

Survey of state and local government and politics with special reference to the constitution and politics of Texas. This course provides an in-depth examination of the structures, functions, and processes of state and local governments in the United States.

Course Objectives and Outcomes

By the end of this course, students will be able to:

- 1. Evaluate the principles of state constitutions, including the Texas Constitution, analyzing their similarities and differences with the U.S. Constitution and their impact on state governance.
- 2. Examine the dynamic relationship between federal, state, and local governments, analyzing how this balance has evolved over time and its impact on policy implementation at different levels of government.
- 3. Analyze the mechanisms of state and local democracy, including elections, political parties, and interest groups, and their influence on policy-making at the state and local levels.
- 4. Demonstrate an understanding of how public policy is formulated, implemented, and evaluated at the state and local levels, using case studies from areas such as education, criminal justice, or environmental policy.
- 5. Examine the factors that influence political behavior and public opinion in state and local contexts, including media, socioeconomic factors, and demographic characteristics.
- 6. Construct comprehensive analyses of current state and local political issues, incorporating constitutional principles, institutional roles, and policy implications specific to state and local governance.
- 7. Compare and contrast the structures and functions of state executive, legislative, and judicial branches, with a particular focus on Texas government.
- 8. Analyze the roles, responsibilities, and challenges of local government entities, including counties, municipalities, and special districts.

Assignments and Examinations

1. Weekly In-Class Assignments (25%, 195 points)

Your weekly assignments are divided into two components:

a. In-Class Activities (13 x 10 points each, 130 points total)

• Every week, you will participate in an interactive in-class activity related to the week's topic. These activities are designed to apply concepts learned during lectures and encourage active engagement. Activities will vary and may include debates, simulations,

case studies, or group problem-solving exercises. These must be completed in class and cannot be made up if missed, except for approved excused absences.

b. TopHat Discussions (13 x 5 points each, 65 points total)

• Each week, a discussion prompt will be posted on TopHat. You are required to post an initial response (worth 3 points) and two replies to classmates (worth 1 point each). Initial responses are due by Wednesday at 11:59 PM, and replies are due by Friday at 11:59 PM. This must be completed on time and cannot be made up if missed.

2. Reflection Papers (20%, 100 points)

You will submit four original reflection papers throughout the semester via eLearning.

• Each paper is worth **33 points** (4 papers x 25 points each = 100 points total). Papers should be **500-750 words** long. Use 12-point Times New Roman font, double-spaced, with 1-inch margins. Include your name, date, and assignment title at the top of the first page. Cite any outside sources using APA format. Submit via eLearning by 11:59 PM on the due date. Due dates: **September 15, October 6, November 17.**

IMPORTANT: I expect a good level of writing from ALL STUDENTS on these papers. Take this directive seriously and put significant thought and effort into your papers. Show me what you've learned and relate it back to our class. Your grade will reflect your effort.

USE OF ARTIFICIAL INTELLIGENCE TOOLS STRICTLY PROHIBITED: Students are not allowed to use advanced automated tools (artificial intelligence or machine learning tools such as ChatGPT or similar) on ANY PART of assignments or exams for this course. Each student is expected to complete each assignment without substantive assistance from others, including automated tools. <u>Violations will result in a zero on the assignment and referral to the Office of Student Conduct.</u>

• Multiple-choice Questions, True/False Questions, Matching Questions, Short answer Questions. Total time: 50 minutes. Exams will be taken in-person in the classroom during regular class time on your personal laptop. You may bring one page of handwritten notes only. Electronic devices other than your testing laptop are not allowed. Exams are but closed-book. You may not access your textbook or the internet during the exam. You must bring your fully charged laptop and your UTD ID on exam days.

1. Course Overview and Expectations

This is a semester-long course. Students will be evaluated on all course materials, including lectures, assigned readings, in-class discussions, and any guest presentations during the semester.

Regular attendance and active participation are crucial for success in this course. It will be critical that you attend class and key notes will not be sent to students for any classes missed unless there are excused absences, official accommodations from the Office of AccessAbility, or per the current UTD COVID isolation policy.

2. Class Attendance/Participation (5% of final grade)

As an in-person course on American National Government, your attendance and active participation are expected for every class unless you have an excused absence per UTD policy. Please demonstrate respect for the instructor, guest speakers, and your fellow students by:

- Arriving on time
- Remaining in the classroom for the duration of the session
- Engaging actively in discussions and activities
- Not leaving the classroom once it starts

The instructor reserves the right to also deduct class participation points for negative student behaviors that adversely affect the classroom. Another classmate may NOT sign in for you for in person classes—this will be considered to be an act of academic dishonesty. Students can get class participation points by interacting with the professor and your fellow students in assigned class activities, via emails to your instructor, by asking questions during class time, or via virtual office hours appointments. Simply put, and most relevant to your grade and learning, if you are not attending, you will not be able to participate or prepare well for your exams and this will negatively affect your score in this course. I will reward students who attend class with insights into exam questions and other relevant information with key points that will help them to be successful in the class.

It is solely YOUR responsibility to get notes from classmates for whatever classes are missed in person. Make a friend at the beginning of the semester that you can count on if an emergency comes up and you cannot attend class.

3. Communication Policy

A word of caution about communications with other students outside of eLearning: if you have questions or concerns about this course at any time, you are strongly urged to send the class TA (cc: Dr. Medhi) an email or visit during office hours and avoid negative spaces (including GroupMe or other social media platforms) that may misinform or provide you false information. This syllabus provides a huge amount of information and should always be consulted prior to reaching out to other students if there is any confusion on assignments, due dates, and other requirements.

4. Excused Absences

Excused absences are limited to observed religious holidays per UTD policy, military service, or official UTD events (athletics, debate, Moot Court, etc.) or due to COVID-related exposure or serious illness that students notify me of IN ADVANCE via email or in person.
