General Course Information

Pre-requisites, Co- requisites, & other restrictions	Pre-requisite: Organic Chemistry I (CHEM 2323)
Course Description	This course is a continuation of Introductory Organic Chemistry I (CHEM 2323). You are expected to be familiar with the concepts covered in chapters 1 – 10 of the assigned book. Emphasis is placed on the use of reaction mechanisms for understanding the chemical transformations, and the employment of a variety of functional groups and reaction types to the synthesis of organic molecules. Spectroscopy of organic molecules is also studied. The course notes used during lectures can be downloaded as pdf files from E-Learning. Problems and supplementary material will also be posted on E-Learning.
Learning Outcomes	 Upon completing this class students will learn: the chemistry of various functional groups to use spectroscopy to characterize organic molecules predict the mechanisms of organic reactions design synthetic routes for the synthesis of desired organic compounds

Student Grievance Procedures	Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's <i>Handbook of Operating Procedures</i> . In attempting to resolve any student grievance regarding grades, evaluations, or other

	fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties. Incomplete Grades	As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.
If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
