### *General Course Information*

**Pre-requisites, Co-requisites, & other restrictions**    Pre-requisite: Organic Chemistry I (CHEM 2323)

#### **Course Description**

This course is a continuation of Introductory Organic Chemistry I (CHEM 2323). You are expected to be familiar with the concepts covered in chapters 1 – 10 of the assigned book. Emphasis is placed on the use of reaction mechanisms for understanding the chemical transformations, and the employment of a variety of functional groups and reaction types to the synthesis of organic molecules. Spectroscopy of organic molecules is also studied.

The course notes used during lectures can be downloaded as pdf files from E-Learning. Problems and supplementary material will also be posted on E-Learning.

#### **Learning Outcomes**

Upon completing this class students will learn:

- the chemistry of various functional groups
- to use spectroscopy to characterize organic molecules
- predict the mechanisms of organic reactions
- design synthetic routes for the synthesis of desired organic compounds

	<p>fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called “the respondent”). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent’s School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean’s decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the dean will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.</p> <p>Copies of these rules and regulations are available to students in the Office of the Dean of Students, where staff members are available to assist students in interpreting the rules and regulations.</p>
<b>Incomplete Grades</b>	<p>As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester’s end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester.
