BLAW 2301.HON – FALL 2013 CLASS EXPECTATIONS

PURPOSE

I am outlining some of my expectations of you so you know up front what I expect of students in my classes. I am doing this so there is no confusion about the consequences to you and your grade for failing to meet these expectations. This also allows me to be fair to all students.

This is not a complete listing of the rules of the class. I reserve the right to alter, add to, or delete from these rules as I see fit.

CLASS ATTENDANCE

Rules:

- 1. Be on time
- 2. Pay attention and take notes
- 3. Do not disrupt class
- 4. It is your responsibility to sign the attendance sheet in order to be counted present
- 5. Do not sign in others when they are not present or have them sign you in when you are not present

Consequences:

- 1. Class disruptions may lead to removal from class
- 2. Failure to sign the attendance sheet will result in you being counted absent
- 3. I reserve the right to make additional adjustments to your overall course letter grade based on your ATTENDANCE and ATTENTION in class. Just to warn you this may SIGNIFICANTLY REDUCE your grade!!

EXAMS

Makeup Exams

A makeup exam may be given at my discretion, and only for very compelling reasons and with proper documentation. The makeup exam may be another format of exam (including a paper, essay questions, short answers, etc.).

Communication is the key in the event that you require a makeup exam. The sooner you can communicate with me the better. One of the first things that I will consider in making a determination about granting a makeup exam is your class attendance.

Late to Exam

If you are late to an exam it is VERY disruptive to your classmates. I will deduct one point for each minute you are late to the exam. If one (1) student finishes the exam and leaves the classroom before you arrive, you will <u>NOT</u> be allowed to take the exam – this means you will receive a <u>ZERO</u>!!!

ASSIGNMENTS

- 1. You <u>MUST</u> follow the assigned format of all assignments
- 2. Failure to follow the assigned format results in <u>SUBSTANTIAL</u> deductions. You may receive <u>ZERO</u> credit for these assignments if proper format is not followed
- 3. You <u>WILL</u> receive <u>SUBSTANTIAL</u> deductions for sloppy/unprofessional work. Sloppy/unprofessional work may result in a grade of <u>ZERO</u>
- 4. <u>NO LATE ASSIGNMENTS ACCEPTED</u>!!

CLASSROOM CITIZENSHIP

I expect that students will act in a professional and courteous manner towards their classmates and towards me. Differing views should be respected. I reserve the right to have you removed from class if your behavior becomes dangerous, disruptive, or disrespectful.

- <u>Assignments</u> Grade of ZERO (0) for the assignment, the writing assignment grades of zero cannot be dropped or replaced
- <u>Attendance</u> loss of all attendance points awarded for the semester
- <u>Other graded assignments not addressed above</u> will receive a zero on the assignment or an F for the course based on the weight of the assignment.
