Course Description

This lecture and lab course covers fundamentals of microwave design and measurements. Microwave components will be designed and simulated with various CAD tools and then built and measured to compare performance with theory. The lab will involve learning the basics of accurate microwave measurements, including vector impedance (scattering parameters), scalar measurements and spectrum analysis.

Student Learning Objectives/Outcomes

- Ability to apply fundamental RF principles to design of resonant structures
- Ability to design, build and test microwave directional couplers and power dividers
- Ability to design and implement impedance matching networks for a microwave amplifier

Incomplete Grade Policy
