Course Description

The application of statistical methods to economic analysis; particular attention is given to regression analysis and hypothesis testing. This course also offers an introduction to the application of econometric methods to real datasets, through the usage of STATA.

This course will allow you to build the analytical and quantitative skills necessary to work with and interpret economic data through the use of econometric tools. You will also develop precious applied skills through the use of STATA.

Grading Policy

If the student decides not to take the final exam, the final grade will be calculated as follows: 1st Midterm 30%, 2nd Midterm 30%, Project 25%, Assignments 15%

If the student does not feel satisfied with his/her performance on the midterm exams, he/she can choose to take a cumulative final exam. In that case, the final grade will be calculated as follows.

Average of the 2 midterms 10%, Final exam 50%, Project 25%, Assignments 15%.

Remember: the midterms are designed to make you able to be tested on a smaller portion of the material at a time. Make sure you are prepared for them, as relying on one single, cumulative exam can be a risky choice.

Make-up exams

Extra Credit

To incentivize attendance to the Friday STATA labs, I will give 5 extra credit points to be allocated to one of the 2 midterm exams, to those students that attend at least 85% of the lab sessions.

Late Work

No late work will be accepted. Again, under extreme circumstances and with previous notification from students, I might consider allowing you to turn in an assignment late. A penalty will be assessed in this case, as 15% of the score will be deducted for each extra day the assignment is late. After a week from due date, you will earn a grade of 0.

Class attendance is HIGHLY RECOMMENDED. Also, I encourage you to attend all STATA labs, as I will show you how to apply the content studied in class to real datasets; I am also going to show how to work in STATA problems similar to those assigned in the problem sets.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed.
