# **Course Description**

An introductory lab on the basic fundamentals of physics. Students will learn about the following topics: personal computer-based data presentation and curve fitting, basic measurement concepts, experimental uncertainty, mean, standard deviation, standard error, and error propagation.

# **Student Learning Objectives/Outcomes**

Upon completing this course, students will:

- 1. Be able to prepare lab reports including data, calculations, and analysis.
- 2. Be able to present data graphically and analyze it.
- 3. Be able to classify all types of error, how to determine them and how they affect results.
- 4. Demonstrate understanding of linear motion (displacement, velocity, acceleration), forces, and conservation of energy and momentum

# **Course Policies**

- 1. All students are required to attend the laboratory session in which they have registered Any student who attends a different laboratory session will get an F in his registered course. No exceptions.
- 2. You must do all labs. There are no dropped grades.
- 3. If for any reason the student can not make it to his lab, the student must do 3 things to get permission to make up the lab in another section: (Contact info for lab TAs will be on eLearning under your lab)
  - a. Contact Dr. Glosser at <a href="mailto:glosser@utdallas.edu">glosser@utdallas.edu</a> and bring written proof of a conflict or illness.
  - b. Contact your normal lab TA about the problem.
  - c. Contact the lab TA that is in the lab you can attend.
- 4. Each student must turn in his or her own lab report in his or her own words. You work as a group during the lab to take data, not to write the lab report. You must do the write-ups yourself.

  Violators will be prosecuted.
- 5. Read Writing Lab Reports on eLearning\_before writing labs. *Again each person must write his own lab report.* No exceptions. The formal lab reports for Labs 4 & 9 must have all parts, but the informal write-ups for the other labs will only need data and the answers to the questions. But look at how to do calculations here.
- 6. Labs will be checked for plagiarism. See the section on academic integrity below.
- 7. **No late reports will be accepted**. (For the exception of missing a lab (as detailed in 2) do the following. The lab report must be turned into your sections lab TA as soon as possible and must include the initials of the lab TA of the session attended.)
- 8. Active participation in all labs are required. Each student is required to take at least one independent set of data in each experiment.
- 9. Each student should stay in the lab until they have the questions at the end of the lab answered and the data tables completely filled in.

- 10. Labs must be initialed by TA before you leave your lab section. The initialed page must include all filled in data tables and be attached to your final lab report. If the initialed page is not attached, the lab receives an automatic zero. You should keep a Xeroxed copy of this initialed page for your records in case you need it.
- 11. Labs must be read before coming to the lab session and all tables filled in before leaving. Pop quizzes in lab and prequizzes on eLearning before lab could be assigned.
- 12. Labs will consist of a brief summary of the principles behind the lab, an explanation of how the lab is done, and the lab itself. Then the write up must be finished and turned into the lab TA by the beginning of the next lab.
- 13. Grades will be based on participation and the write-up. Help your group!
- 14. Also note to keep an eye on your grades under your lab on eLearning. It is your responsibility to make sure the grades are there and accurate. If there are any problems you must bring them up to the attention of the TA or me as soon as possible. It is also helpful to keep a copy of the report you turn in and the graded report till the end of the semester in case of any grading issues. All issues should be brought to my attention by the end of the semester.
- 15. It is also important to realize some of your labs will be graded on accuracy of your data. Be careful and make sure your equipment is working properly (zeroed balances, reasonable percent errors, etc.).

# **Student Conduct & Discipline**

#### **Academic Integrity**

The faculty expects from its students a high level of responsibility and academic honesty. Because the value of an academic degree depends upon the absolute integrity of the work done by the student for that degree, it is imperative that a student demonstrate a high standard of individual honor in his or her scholastic work.

Scholastic dishonesty includes, but is not limited to, statements, acts or omissions related to applications for enrollment or the award of a degree, and/or the submission as one's own work or material that is not one's own. As a general rule, scholastic dishonesty involves one of the following acts: cheating, plagiarism, collusion and/or falsifying academic records. Students suspected of academic dishonesty are subject to disciplinary proceedings.

Plagiarism, especially from the web, from portions of papers for other classes, and from any other source is unacceptable and will be dealt with under the university's policy on plagiarism (see general catalog for details). This course will use the resources of turnitin.com, which searches the web for possible plagiarism and is over 90% effective.

# **Email Use**

The University of Texas at Dallas recognizes the value and efficiency of communication between faculty/staff and students through electronic mail. At the same time, email raises some issues concerning security

and the identity of each individual in an email exchange. The university encourages all official student email correspondence be sent only to a student's U.T. Dallas email address and that faculty and staff consider email from students official only if it originates from a UTD student account. This allows the university to maintain a high degree of confidence in the identity of all individual corresponding and the security of the transmitted information. UTD furnishes each student with a free email account that is to be used in all communication with university personnel. The Department of Information Resources at U.T. Dallas provides a method for students to have their U.T. Dallas mail forwarded to other accounts.

#### Withdrawal from Class

The administration of this institution has set deadlines for withdrawal of any college-level courses. These dates and times are published in that semester's course catalog. Administration procedures must be followed. It is the student's responsibility to handle withdrawal requirements from any class. In other words, I cannot drop or withdraw any student. You must do the proper paperwork to ensure that you will not receive a final grade of "F" in a course if you choose not to attend the class once you are enrolled.

#### **Student Grievance Procedures**

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Copies of these rules and regulations are available to students in the Office of the Dean of Students, where staff members are available to assist students in interpreting the rules and regulations.

# **Incomplete Grade Policy**

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of  $\mathbf{F}$ .

#### **Disability Services**

The goal of Disability Services is to provide students with disabilities educational opportunities equal to those of their non-disabled peers. Essentially, the law requires that colleges and universities make those reasonable adjustments necessary to eliminate discrimination on the basis of disability. For example, it may be necessary to remove classroom prohibitions against tape recorders or animals (in the case of dog guides) for students who are blind. Occasionally an assignment requirement may be substituted (for example, a research paper versus an oral presentation for a student who is hearing impaired). Classes enrolled students with mobility impairments may have to be rescheduled in accessible facilities. The college or university may need to provide special services such as registration, note-taking, or mobility assistance.

It is the student's responsibility to notify his or her professors of the need for such an accommodation. Disability Services provides students with letters to present to faculty members to verify that the student has a disability and needs accommodations. Individuals requiring special accommodation should contact the professor after class or during office hours.

# **Religious Holy Days**

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
