# Course Pre-requisites, Co-requisites, and/or Other Restrictions

A score of 55% on ALEKS math placement exam or a grade of at least a C- in MATH 1314

### **Course Description**

This course covers the following topics: a review of basic concepts in algebra, functions and graphs, differentiation, maxima and minima, exponential and logarithmic functions, integration, and applications of integrals.

#### **Student Learning Outcomes**

- 1. Students will be able to formulate real world problems into mathematical statements.
- 2. Students will interpret a narrative description of a situation and set up variables and relationships needed to determine a solution.
- 3. Students will be able to develop solutions to mathematical problems at the level appropriate to thi course (i.e. apply the principles and techniques of differential and integral calculus).
- 4. Students will be able to describe or demonstrate mathematical solutions either numerically or graphically.

### **Required Materials**

- 5. A MyMathLab access code. This also provides access to an electroic copy of the textbook. You must access MyMathLab through eLearning.
- 6. Access to a computer capable of running Chrome, Firefox, or Safari web browser.
- 7. Access to a printer and stapler.

### **Optional Materials**

- 1. Textbook: *Calculus with Applications 10th Edition*, by Lial, Greenwell, and Ritchey **Note:** The bookstore has both a hardcover and looseleaf version of the book, both of which include a MyMathLab access code.
- 2. Calculator: Any non-graphing, scientific calculator which cannot perform calculus operations is allowed on exams. You will not need a calculator, and if you bring one it will be checked during the exam.

Digital Homework: Every Tuesday a new assignment will be posted on MyMathLab which will be due by 11:59PM on Wednesday of the following week. Your DHW average will be calculated after dropping the lowest two scores.

Take-home Quizzes: These will be posted on eLearning every Thursday by midnight. You must download, print, complete, and staple THQs. With the exception of THQ1, THQs must be submitted at the beginning of the lecture on the following Tuesday. Your THQ average will be calculated after dropping the lowest two scores.

Exams: There will be three standard exams and one comprehensive final exam. All four exams will be taken in class. The weights of the first three exams depend on your performance: your lowest exam score will be worth 10% of your term grade, your highest will be worth 20%, and the middle will be worth 15%.

#### **Email Use**

### Withdrawal from Class

The administration of this institution has set deadlines for withdrawal of any college-level courses. These dates and times are published in that semester's course catalog. Administration procedures must be followed. It is the student's responsibility to handle withdrawal requirements from any class. In other words, I cannot drop or withdraw any student. You must do the proper paperwork to ensure that you will not receive a final grade of "F" in a course if you choose not to attend the class once you are enrolled.

### **Student Grievance Procedures**

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's *Handbook of Operating Procedures*.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

### **Incomplete Grade Policy**

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of  $\mathbf{F}$ .

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
