Course Pre-requisites, Co-requisites, and/or Other Restrictions

Co-requisite: EE/CE/TE 3302 Signals and Systems; Pre-requisite RHET 1302

Course Description

In this lab course, students will acquire hands-on experience in software implementation of the theory and concepts covered in the signals and systems lecture course EE3302. The software tools that are utilized include both MATLAB and LabVIEW. The labs consist of introduction to LabVIEW, introduction to MATLAB, convolution and linear time-invariant systems, Fourier series, continuous-time Fourier transform, sampling and aliasing, discrete Fourier transform, and analysis of analog and digital systems. Each lab consists of a learning session and a design session.

Course Learning Objectives

- Implement and examine convolution of signals and linear time-invariant systems
- Implement and examine Fourier series
- Implement and examine continuous-time Fourier transform
- Implement and examine sampling, aliasing, and discrete Fourier transform
- Utilize hybrid programming (combination of MATLAB and LabVIEW) to implement signals and systems problems

Lab Organization

Attendance is taken at the beginning of each lab via sign-up sheet. Please note that you only have 10 minutes to physically sign in your attendance. If you are more than 10 minutes late for a lab session, you will not receive the attendance credit for that lab session.

It is necessary to understand the theory behind each lab, which is covered in the accompanying lecture course EE3302. Read the lab manual of a lab session before that lab session. Most labs consist of two sessions spanned over two weeks. For the first session of a lab, the materials covered in the lab manual are implemented. 45 minutes before the end of the first session, a quiz will appear on eLearning based on the materials covered. The quiz solution must be uploaded to the eLearning website by the end of the first lab session. No late quiz solution will be accepted or can get uploaded to eLearning.

To prepare for the second session of a lab, remedy any difficulties or deficiencies you encountered during the first session by going to the open lab located in ECSN 4.324 and redoing the first session materials. In the second session, you are given a design problem or problems to implement based on the materials learned in the first session. A lab report together with codes for these problems must be uploaded to the eLearning website by the end of the second lab session. No late lab report/code will be accepted or can get uploaded to eLearning.

The labs are to be done individually. Note that you are responsible for saving your work on a memory device or email it to a permanent storage location at the end of each lab. The machines are set up in such a way that your work directory gets automatically deleted when logging off.

Lab Quizzes/Reports

You must write your own codes and reports.

<u>Copying of codes or reports, no matter how small, is absolutely not allowed and will be regarded as a violation of the academic honesty code.</u>

Lab reports are to be typed and should include not more than a one-page discussion of results together with a snapshot of the Front Panel and Block Diagram of your code including .vi and .m files.

A softcopy of your codes (.vi and .m files) along with your quiz/lab report should be placed into a folder and get uploaded to the eLearning website. The names of your folder, files, and codes should follow the following naming convention: *section#-lastname-quiz#/report#*

This course will use the resources of turnitin.com, which searches the web for possible plagiarism and is over 90% effective.

Email Use

The University of Texas at Dallas recognizes the value and efficiency of communication between faculty/staff and students through electronic mail. At the same time, email raises some issues concerning security and the identity of each individual in an email exchange. The university encourages all official student email correspondence be sent only to a student's U.T. Withdrawal from Class

The administration of this institution has set deadlines for withdrawal of any college-level courses. These dates and times are published in that semester's course catalog. Administration procedures must be followed. It is the student's responsibility to handle withdrawal requirements from any class. In other words, I cannot drop or withdraw any student. You must do the proper paperwork to ensure that you will not receive a final grade of "F" in a course if you choose not to attend the class once you are enrolled.

Student Grievance Procedures

Procedures for student grievances are found in Title V, Rules on Student Services and Activities, of the university's Handbook of Operating Procedures.

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of \underline{F} .

Essentially, the law requires that colleges and universities make those reasonable adjustments necessary to eliminate discrimination on the basis of disability. For example, it may be necessary to remove classroom prohibitions against tape recorders or animals (in the case of dog guides) for students who are blind. Occasionally an assignment requirement may be substituted (for example, a research paper versus an oral presentation for a student who is hearing impaired). It is the student's responsibility to notify his or her professors of the need for such an accommodation. Religious Holy Days

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
