Class Attendance	Students will lose 5 points from their final grade if they miss more than 3 classes (until three absences, there is no penalty in grade). Assignment & Exams

<u>Term project</u>: Students will work on a project of starting a Texas-based 501(c)(3) nonprofit corporation in your area of interests. In order to qualify as a 501(c)(3), your organizations must serve one of the purposes that are categorized as exempt purposes under section 501(c)(3). The instructor will provide more explanations about this project in class and on elearning. In presenting your project, avoid the use of video clips as they consume too much presentation time.

Exams: Both mid-term and final exams will consist of multiple choice, short answer, and matching questions. Bluebooks are not necessary. The final exam will be comprehensive, covering all the topics discussed during the semester.

<u>Case study</u>: In writing their case analysis, students must use the concepts and theories discussed in the class in order to support their arguments/opinions. Cases will be made available two weeks before the deadline.
