Leaders in both the private and public sector need to be responsive to the ever constant changing landscape of information technology and how it can significantly enhance organizational operations.

Course Description

Public sector organizations are continually challenged to understand, use, and adapt to new information systems and communications technologies as they emerge. We continue to see ways that new information systems and technologies change how public affairs professionals interact, work, and serve the public. How can public sector organizations best harness these systems to provide better public services? What is the role of public policy to regulate issues surrounding the use of these technologies? This course will explore the relationships between information systems and government management, decision making, and public policy. During the semester, students will explore current trends and cutting-edge technologies in real-time.

- To understand how politics and policies surrounding the use of technology impact public affairs
- To appreciate the benefits and challenges information systems bring to the public affairs arena
- To gain an enhanced understanding of the processes and challenges encountered when implementing and using information systems in public organization settings
- To appreciate how information systems can be used to inform policy decisions
- To be exposed to trends and implications of evolving technology

Assignments

Class Preparation, Participation & Discussion Postings (30%)

Students are expected to complete required readings prior to class. Discussions held in class are derived from assigned readings and postings, therefore, it is essential that students be able to demonstrate comprehension of selected topics. Postings and discussions should go beyond simply summarizing the articles. Students are encouraged to discuss current issues and apply their own real-world experience as they may relate to course discussions and topics.

Reflection Papers (40%)

Reflection papers should present your thoughts in a clear and organized way, addressing the particulars of the respective assignment. Papers will be evaluated based on the degree to which the student follows the assignment prompt and demonstrates an understanding of the assigned reading material as well as the implications for public policy and public affairs.

Final Examination (30%)

The final exam is an essay that covers topics presented during the course. Additional details will be announced in class.
