## **Course Pre-requisites**

Since the professional portfolio management industry has relied increasingly more on quantitative analyses, significant mathematical and statistical knowledge is required for this course, especially, knowledge on probability distributions and regression analysis. It is also very important to review basic principals and concepts of investment management. Proficiency in Excel statistical tools is required. Investment Management (FIN 6310) and Statistics 5311 or equivalent are prerequisites.

## **Course Description**

This course is a Master-level elective course that focuses on the theory and practice of modern portfolio management. In addition to providing in-depth discussions of portfolio construction, monitoring and evaluation, it will allow students to gain hands-on experience through case study and portfolio simulation. Major topics will include asset pricing models, equity and bond portfolio management, performance evaluation, and new developments in professional asset management. Students targeting the professional asset management career or planning to take the CFA test will find this course particularly useful.

## **Student Learning Objectives/Outcomes**

- Students will understand the basic portfolio theories and their implications for portfolio construction and management
- Students will understand and be able to apply equity and bond portfolio management strategies and portfolio performance evaluation methods
- Students will gain hands-on experience in managing portfolios via case study and trading simulation

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. #### **Incomplete Grade Policy**

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of  $\underline{F}$ .

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee.
