Course Pre-requisites, Co-requisites, and/or Other Restrictions

Pre-requisite: No Prerequisites but background in linear algebra, computer programming, experimental psychology, and/or neuroscience will be very helpful.

Course Description

Computational Neuroscience, Cognitive Neural Modeling, Mathematical Psychology, and Machine Learning methodologies are introduced through the use of computer-based simulation modeling experiment. Machine learning architectures include: supervised learning, unsupervised learning, self-organizing networks, and reinforcement learning algorithms. MATLAB software is used to create a "hands-on" laboratory environment. Applications to problems in modeling behavioral and brain processes as well as artificial intelligence.

Student Learning Objectives/Outcomes

- 1. Understand the Role of Models in the areas of Psychology, Neuroscience, and Machine Learning
- 2. Understand key ideas in Neural Net Math including: distributed representations, linear subspaces and gradient descent
- 3. Understand the differences between Supervised, Unsupervised, Self-Organizing, and Reinforcement Learning methods and how to select the appropriate learning method for specific applications
- 4. Understand the concept of constraint satisfaction algorithms including genetic algorithms and model selection algorithms.
- 5. Understand the relevance of Machine Learning for Model Building and Theory Development in the fields of Cognition, Neuroscience, and Artificial Intelligence.

Assignments & Academic Calendar

Lab Assignments

All lab assignments will be completed on-line. Students may discuss lab assignments among themselves by posting questions to the class discussion board for that module. Lab assignments will be available approximately 1 week before the lectures for that module and will be due approximately 1 week after the lectures for that module. *Late lab assignments will not be graded*.

Review Paper

Each student will be required to present at the end of the course a *final paper* which describes an application of neural network technology to their particular area of interest (e.g., neuroscience application, application in computer science, application in artificial intelligence). Your should be be a review of a journal article that was published in a journal such as *"Neural Networks"*, *"Journal of Computational Neuroscience"*, *"Neural Computation"*, or in the Neural Information Processing Systems Conference (<u>https://papers.nips.cc/</u>). The final paper should be 5-9 pages long, 1.5 inch line spacing, 1 inch margins, 12 pt font, and be written in the format described in the lecture notes with approximately 1-2 pages devoted to the introduction (why they did it) (25% of grade), 1-2 pages devoted to the results (what they found) (25% of grade), and 1-2 pages devoted to the discussion section (why are the results important) (25% of grade).

<u>Please submit a PDF copy of a journal article you have read that is most closely related to your</u> <u>submission!!!.</u>

Note that the review paper is not simply the description of an algorithm and some algorithm output. It must emphasize a practical application in an areas such as: artificial intelligence (which requires describing why the problem in artificial intelligence is important), cognitive psychology (which requires describing relevant cognitive behavioral data model explains), or neuroscience (which requires describing relevant neuroscience data model explains).

This course will use the resources of turnitin.com, which searches the web for possible plagiarism and is over 90% effective.

Email Use

Student Grievance Procedures

In attempting to resolve any student grievance regarding grades, evaluations, or other fulfillments of academic responsibility, it is the obligation of the student first to make a serious effort to resolve the matter with the instructor, supervisor, administrator, or committee with whom the grievance originates (hereafter called "the respondent"). Individual faculty members retain primary responsibility for assigning grades and evaluations. If the matter cannot be resolved at that level, the grievance must be submitted in writing to the respondent with a copy of the respondent's School Dean. If the matter is not resolved by the written response provided by the respondent, the student may submit a written appeal to the School Dean. If the grievance is not resolved by the School Dean's decision, the student may make a written appeal to the Dean of Graduate or Undergraduate Education, and the deal will appoint and convene an Academic Appeals Panel. The decision of the Academic Appeals Panel is final. The results of the academic appeals process will be distributed to all involved parties.

Incomplete Grade Policy

As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of $\underline{\mathbf{F}}$.

Essentially, the law requires that colleges and universities make those reasonable adjustments necessary to eliminate discrimination on the basis of disability. Religious Holy Days

The University of Texas at Dallas will excuse a student from class or other required activities for the travel to and observance of a religious holy day for a religion whose places of worship are exempt from property tax under Section 11.20, Tax Code, Texas Code Annotated.

The student is encouraged to notify the instructor or activity sponsor as soon as possible regarding the absence, preferably in advance of the assignment. The student, so excused, will be allowed to take the exam or complete the assignment within a reasonable time after the absence: a period equal to the length of the absence, up to a maximum of one week. A student who notifies the instructor and completes any missed exam or assignment may not be penalized for the absence. A student who fails to complete the exam or assignment within the prescribed period may receive a failing grade for that exam or assignment.

If a student or an instructor disagrees about the nature of the absence [i.e., for the purpose of observing a religious holy day] or if there is similar disagreement about whether the student has been given a reasonable time to complete any missed assignments or examinations, either the student or the instructor may request a ruling from the chief executive officer of the institution, or his or her designee. The chief executive officer or designee must take into account the legislative intent of TEC 51.911(b), and the student and instructor will abide by the decision of the chief executive officer or designee.
