General Course Information

Course Description

Youth Crime and Justice Examines the concept of juvenile delinquency as a distinct type of criminal activity from that committed by adults and assesses the distinct juvenile justice system that has evolved to handle children. Topics will include the historical roots of delinquency and the juvenile justice system, delinquency measurement, explanations of delinquency, and the socio-demographic correlates of delinquency status

Student Learning Objectives/Outcomes

- 1. To understand the historical origins of the juvenile justice system
- 2. To understand the contemporary juvenile justice system and how it has evolved from the original juvenile justice system in light of both contemporary criminal justice advancements and historical happenings
- 3. To understand and identify major theoretical explanations for juvenile delinquency as well as the potential social causes
- 4. To critically assess the intervention programs at the various stages of the criminal justice system that are designed to address juvenile delinquency

Required Textbooks and Materials

Required Texts

Exams: There will be four (4) exams this semester. The first three exams will be worth 50 points and will be comprised of 25 questions: multiple choice, short answer, and true/false questions which will be based on class lecture and assigned readings. The test will cover all of the information covered in the required text, readings, lecture, presentations, and class discussions. Final exam has 50 Questions and is worth a 100 points.

The dates noted on the syllabus for the first three exams are tentative and are subject to change - any changes will be announced in class. The final exam has been set by the university.

Assignments 200 points

There are no group assignments in this class. Each student must complete his or her work individually, and turn in assignments by due date and according to professor instructions. There will be four (4) assignments in this class. Each assignment is worth **50 points**, for a total of **200 points**. Assignments will include a variety of activities, including in-class group work, independent research, class presentations, and on/off-campus activities.

Attendance/Participation: 50 Points

You are required to attend class. The professor will take attendance at either the beginning or end of class and on random days. Students are responsible for ALL material covered in class, whether you are in class or not. Therefore, it is advised that you make a friend in class who would be willing to share class notes with you and you with them. It is expected that students will participate in classroom discussions as appropriate. In order to facilitate this, classroom participation will be included as part of students' grades. Participation will be measured in a variety of ways, including use of in classroom activities, engaging actively in discussion with the professor and classmates, attendance, and utilizing eLearning activities as directed.

Grading Criteria

There are a total of 500 points which may be earned throughout the course. Students are encouraged to maintain a record of their grades.

Course Policies Required Course Technology eLearning:

This course utilizes a web page tool called **eLearning** to provide easy access to important course information. You must be registered for this class to log on to the site. You will use the web site to take your quizzes, obtain class information, check announcements, and receive your assignments. Incomplete Grade Policy: As per university policy, incomplete grades will be granted only for work unavoidably missed at the semester's end and only if 70% of the course work has been completed. An incomplete grade must be resolved within eight (8) weeks from the first day of the subsequent long semester. If the required work to complete the course and to remove the incomplete grade is not submitted by the specified deadline, the incomplete grade is changed automatically to a grade of F.

Keep in mind that simply missing class, email, or eLearning announcements does not delay deadlines. **Make-up Exams** Makeup exams will be provided for students who have a university recognized excused absence. The final decision to excuse absences is left to the discretion of the professor. In most instances, students will be required to provide written documentation for your absence. In addition, you MUST talk with an instructor prior to the date of the exam in order to schedule a makeup.

Additional material will be added to these lectures and I will highlight material that will be relevant for your exams, so I strongly encourage you to attend class. Students are required to check eLearning for class announcements and course materials several times per week and prior to class so that you are prepared.
