#### **Course Pre-requisites**

There are no formal prerequisites, although it is recommended that students have already taken CRIM 1301 and CRIM 1307. It would also be helpful if students have already taken a basic course in research methods. Students must do the assigned readings in the texts. It is very important to keep up with the readings, which average about 50-75 pages per week.

In addition, all students must be (1) familiar with the use of eLearning, (2) have internet access, and (3) have basic computer skills. **Individuals not comfortable using a computer should NOT attempt to take this course!** If you do not have a fast AND reliable internet connection, you should plan to use UTD computer labs for all coursework. Late work will not be accepted for any reason, so make sure you complete assignments ahead of time if worried about your computer or connection.

#### **Course Description**

The primary purpose of this course is to inform students of what scientific research has to say on a topic that is typically treated as if it were a purely ideological or political issue: the relationship between guns, violence, and gun control. The course provides a comprehensive criminological view of the topic rather than a political or legal one, and concentrates on research and evidence rather than opinions.

#### **Student Learning Objectives/Outcomes**

Students will learn about evaluating evidence, the flaws in arguments for or against stricter gun laws, and the tricks used by advocates to persuade people to agree with their point of view. Most important, however, students should end up well-informed on the facts concerning one of the most heated issues of our times.

#### **Discussion Post Assignments**

You will be required to complete four discussion post assignments. Discussion post assignments are worth 25 points each. You must post a response to a discussion question that **will be made public** to the rest of the class. The response you provide must be a minimum of 2 COMPLETE paragraphs (**250 word minimum**) per discussion question for each post to receive credit. You MAY NOT plagiarize material from the textbook or from any other source (e.g., academic articles, newspaper articles, websites, and so on)! This constitutes plagiarism and even the most minor cases are required to be reported to UTD Judicial Affairs for investigation. Excessive quoting from the textbook is also discouraged.

Discussion posts that do not comply with the guidelines presented herein will be given no credit, no exceptions. Marginal responses will receive reduced or no

credit. Responses that adequately meet all requirements and follow all guidelines will receive a strong score; only those exceeding expectations will receive the highest possible score.

# NOTE: ALL DISCUSSION POSTS WILL BE DUE ON A THURSDAY (BY 11:59 PM (see calendar for specific dates)

Responses should be thoughtful and appropriate. If your response is unclear, illogical, or I suspect that little effort was put into completing it, you will NOT receive full credit for the response. Your responses will be monitored by me so be sure to follow course policy for submissions (see below – proper grammar, punctuation and complete sentences, etc.). You are welcome to write more if you choose and you should strive to use outside sources beyond the text (scholarly articles, **reliable** internet sources (e.g., government websites), current events and etc.) to substantiate your posts. Please refrain from relying on propaganda material from pro & anti-gun advocacy websites (e.g., NRA and Brady Campaign)

You can access the discussion question by clicking the discussions tab on the toolbar. After you have submitted your post, you **MUST respond to ONE other student discussion post**. The response must be thoughtful and appropriate and **at least 125 words**. A sentence or two is NOT good enough. Your discussion grade is based on your post and your peer response. Note that the peer response is due by 11:59 pm on the SUNDAY following the due date of the assignment). **If you do not submit an initial post you cannot receive partial credit for a peer response.** 

It is your responsibility to meet all assignment deadlines noted on the course calendar. NO EXCEPTIONS will be made for late work. Please note that I will be tracking your access to the eLearning course page, so please avoid being dishonest about the time you spend online and the time you spend completing assignments; I'll know whether you're telling the truth! DO NOT WAIT UNTIL THE LAST MINUTE TO SUBMIT ASSIGNMENTS! Excuses such as "I lost internet service" or "eLearning was down!" will not help you. Other excuses that will NOT help you include, but are not limited to, being sick, forgetfulness, work issues, family issues, significant other issues, housing trouble, criminal justice entanglements, and/or computer trouble. Ample time is provided for you to complete assignments on time so please don't waste your time and your excuses on me! These rules will not be bent! All students will be treated equally and held to the same standards!

#### **Quizzes**

There will be a quiz each Thursday (except during Exam weeks), beginning at 6 am and ending at 11:59 pm. Each quiz will consist of 5-10 multiple choice questions and are worth 10 points each. The allotted time on the quizzes is 15 minutes. In other words, once you start the quiz you will have exactly 15 minutes to submit your answers. The quizzes will focus exclusively on the reading assignment for that week. The purpose of the quizzes is twofold. First, the quizzes will serve as an incentive to keep up with the assigned readings (a few of the reading assignments are somewhat

lengthy). Second, the quizzes will prepare you for the types of questions your likely to see on the actual exams. Indeed, selected quiz questions will reappear as exam questions.

#### **Exams**

Students are required to take 3 exams. Each exam is 100 points. Exams 2 and 3 are NOT comprehensive. Exams will consist of multiple choice and true/false questions. All exam material is covered in the course readings and lecture notes. There will be no exam reviews. Exams are taken ONLINE and are timed (75 minutes). Exams are open book/notes, however, you are expected to work individually. If you have not read the material prior to the exam, you will probably do poorly! You will have a **12 hour window** to start each exam; once you begin the clock cannot be reset. The exam questions change each semester.

The 1<sup>st</sup> exam will be held on Wed, September 30<sup>th</sup>. Access starting at 6 am.

The 2<sup>nd</sup> exam will be held on Wed., November 4<sup>th</sup>. Access starting at 6 am.

The 3<sup>rd</sup> exam will be held on Wed., December 9<sup>th</sup>. Access starting at 6 am.

The exam date/time is <u>NOT</u> negotiable. You should arrange your schedule so that you can complete the exams. If you have conflict, you should drop the course and take it during another semester.

IMPORTANT: Make-up exams will absolutely NOT be considered unless there is documented proof of an extreme emergency and I am contacted BEFORE THE EXAM BY EMAIL. Saying you are sick or are you are feeling sick IS NOT A VALID EXCUSE FOR A MAKEUP EXAM. Religious holidays will be fully accommodated, but students must contact me during the first week of classes to make arrangements for a makeup exam. The instructor reserves the right for all makeup examinations to be full essay and be administered on a date of my choosing. If you cannot guarantee that you will be available to take the exams at the above time/dates, please drop this class and take another class that is better suited to your schedule.

#### Late Work

Late assignments will not be accepted for any reason. Ample time will be given for students to complete discussion assignments early if time becomes an issue. If you have ANY doubt that you will be able to make the assignment deadline, you should submit your discussion posts early!

#### Classroom Citizenship

Since this class is web based (on-line), there is no regular in-class attendance. However, discussion posts will be due regularly, thus virtual attendance is a requirement but you will have the freedom to complete the work when it is convenient for you, provided that you meet the deadlines. Students should expect to spend as much time per week completing reading assignments as they would for a regular class.

DO NOT USE THE CHAT ROOM AND DISCUSSION BOARD FOR PERSONAL CHATTING. All communications will be monitored by the professor. Any non-class related communications through eLearning will result in point deductions from grades. REVIEW AND RESPOND TO MY COURSE EXPECTATIONS POST IN THE DISCUSSION FORUM IMMEDIATELY.
