General Course Information

Pre-requisites, Co-requisites, and/or Other Restrictions: Undergraduate course in audiology or consent of instructor

Course Description

This course will review the development, application and interpretation of standard and advanced audiometric test procedures used for diagnosing hearing loss.

Student Learning Objectives/Outcomes

At the conclusion of this course, students will be able to demonstrate an understanding of:

- 1. The history of audiology.
- 2. Case history procedures and interpretation of findings.
- 3. Infection control in audiology.
- 4. Otoscopic examination and interpretation of findings.
- 5. Calibration procedures for audiometric equipment.
- 6. Psychophysical procedures and threshold assessment.
- 7. Bone conduction and tuning fork tests.
- 8. Middle ear measures.
- 9. Speech audiometry.
- 10. Masking principles as they apply to diagnostic audiology.

Grading Policy

Grading for each examination will be based on percentage of correct score as follows:

93-100%* = A 85-92% = B Less than 85% = C

*100% is the highest score obtained by any student. As an example, if the exam has 112 points and the highest score is 104 points, 104 will be the 100% score to base all percentages on. In this case, a score of 94 would be (94/104) 90%.

The course grade will be based on total percentage from the mid term and the final examinations.

Laboratories

The laboratories for this course are scheduled so they compliment the material covered, but are graded separately, so a separate syllabus will be provided.

As part of the laboratories, each student will be required to test 5 adult subjects utilizing: otoscopy, air conduction thresholds, bone conduction thresholds, speech thresholds, word recognition tests, and middle ear measures. The results are to be turned in no later than the last class of the semester.
