### **Course Description**

Working with the Innocence Project of Texas, students will review cases records to determine if a convicted person's case should receive further review by a Project attorney. The key standard is whether there is possibly a legitimate claim of innocence that can be proven in reference to the convicted person's claim.

- 2. To gain an understanding of sources of error in major criminal cases; and,
- 3. To learn to read and analyze court records.
