RESEARCH, TEACHING, AND COMMUNITY SERVICE: OVERVIEW

I am Associate Professor of Sociology in the Sociology Program, Department of Criminology and Sociology, in the School of Economic, Political, and Policy Sciences (EPPS) at The University of Texas at Dallas. I received my Ph.D. from Columbia University in Religious

Studies in 1985; I was awarded a Ph.D. in Systematic Theology by Union Theological Seminary in New York in the same year.

I have published two book monographs on religion and social change; both books were published by the American Academy of Religion and are in the catalogue of Oxford University Press. The first book received grant support from Southern Methodist University. The second book was supported by a grant from the American Academy of Religion (Southwest Commission on Religious Studies) as well as Southern Methodist University. I was one of two primary authors and one of two co-editors of a third book, which was published by The Edwin Mellen Press. The last book was based on a U.S. Department of Education FIPSE grant. I was the PI for the grant project. The book grew out of a refereed, co-authored paper presented at a symposium on college educational opportunities for Hispanic students organized by The Civil Rights Project at Harvard University with support from the Pew Hispanic Center.

My single-author articles have appeared in *Journal for the Scientific Study of Religion*, *Method and Theory in the Study of Religion*, *Journal of Ritual Studies*, *Semeia: Journal for Biblical Interpretation*, and *Listening: Journal of Religion and Culture*. A co-authored article, for which I was the lead author, appeared in the *Journal for Hispanic Higher Education*. I have published book chapters—all as the single author—in edited books by Sage Publications, Inc.; Greenwood Press; Parthian Books; and Brill. I have published entries in two editions of *The Encyclopedia of Religion*, and entries in *Encyclopedia of Protestantism* and *Encyclopaedia Britannica*.

I teach courses on religion in U.S. society, religion in public life (a graduate course), religions in global societies, religion in international development, immigrants and immigration in U.S. society, immigration policy (graduate course), field research methods, qualitative research methods (a graduate course for all EPPS students), and qualitative research practicum, in which EPPS grad students conduct research for their dissertations and Master theses. I was Visiting Scholar in the Social Work Program in the School of Law at Guangdong University of Technology in Guongzhou, Guangdong Province, China, where I taught my UTD course, Field Research Methods, to social work students in May 2016.

I am a two-time recipient of the Student Choice Teaching Award presented by students in the formerly named School of Social Sciences at UTD, have received the Outstanding EPPS Faculty Comet Teaching Award in Sociology in two successive years (2015 and 2016), and a Distinguished Teacher in Diversity and Multicultural Education Award (2014), which is presented by UTD's Office of Diversity and Community Engagement.

The book presents ethnographic findings on barriers Hispanic community college students encounter in transferring to the university. Beyond identifying and analyzing transfer barriers and making suggestions for policy and practice, the ethnographic findings generate a variety of concepts, contexts, and questions for future research. The book is based on a grant project funded by the U.S. Department of Education's Fund for the Improvement of Post-Secondary Education (FIPSE), titled "An Ethnographic/Social-Scientific/Community-Based Model to Recruit and Retain Hispanics." I was Project Director of the grant.

The purpose of the FIPSE grant was to address Congressional Priorities 12 and 13 (1998): retain Hispanic students enrolled in two-year colleges, transfer them to four-year colleges and universities upon the completion of the Associate degree, graduate them with a Bachelor from four-year institutions, and enroll more Latino students as majors in the sciences. The book is an expanded version of a paper I and my co-authors presented at the symposium on "Community Colleges and Latino Educational Opportunity" organized by The Civil Rights Project at Harvard University with support from the Pew Hispanic Center.

By framing the phenomenon within the context of viewers' ideological and social marginalization within mainstream U.S. society, the book calls attention to televangelism's attractiveness as an opportunity viewers discover to redress their marginality. Fundamentalist Christian viewers' ideology and morality differ from those of mainline Christians and of from mainstream society, which is historically committed to political, cultural, and religious pluralism. The book offers an analysis of the conflicting ritual uses of television religion by viewers to overcome their marginality that undermine these efforts: self-legitimation as a minority religious group, and adaptation of members of this

group to a secularized U.S. society undergoing political, social, and cultural change.

• Immigrant Mexican Pentecostal Women's Church Leadership: Toward a Revised Theory of Religion and Women's Empowerment

I currently am working on a book monograph and related journal articles using interpretive and critical ethnography to examine how Mexican immigrant church women from a traditional culture and religion who now reside in the U.S. assert their agency and institutional power in leadership of and/or engagement of their churches, families, workplace, and community organizations while maintaining traditional gender roles associated with these institutions. Such roles include less visible positions in their churches as minor leaders in worship, fundraising, and religious education of children, wife and mother, and gendered or female labor and community organizer. Structures of the workforce, along with paid income in the U.S., and of community organizations heighten opportunities for these church women to assert their agency and power. I also examine how leadership and/or engagement of these institutions encourages and contributes to assimilation of these church women into U.S. social institutions, and, through them, U.S. society. My study contributes to Development Studies a more nuanced understanding of mechanisms and processes through which women of color from traditional religions, cultures, and gender roles in developing countries, and those who migrate to developed ones, achieve institutional agency and power. These traditional, immigrant church women's leadership enlarges or reconstructs concepts of women's agency and institutional power, when Western feminist theory, which excludes women of color, cannot account for them. My research has been funded by the Rockefeller Foundation and CrossCurrents: The Association for Religion in Intellectual Life.

In the final months of the FIPSE grant, I led the successful effort by principals of the FIPSE Project to secure a donor grant from the Dallas Women's Foundation (DWF). The grant, which was awarded through UTD, funded the creation by former FIPSE Project principals of a new 501(c)(3) non-profit organization: the Oak Cliff Center for Community Studies (OCCCS). The OCCCS, which operated out of the physical site of the former FIPSE Project's ethnographic field station in Oak Cliff, continued and expanded the activities of the U.S. Department of Education's FIPSE Project (see above). As President of the Board of Directors of the OCCCS, I wrote and submitted grant applications to a number of foundations, including the Dallas Women's Foundation and the Harold Simmons Foundation.

The OCCCS cooperated with Mountain View College (MVC), UTD's institutional partner in the FIPSE Project, in providing instructional staff for a "Cultural Studies" course offered by MVC originally funded by the FIPSE grant. The OCCCS also made the ethnographic field station it operated available to train students enrolled in the course in ethnographic research. As the FIPSE Project had done, the OCCCS assisted students in applying to four-year institutions, applying for scholarships and other forms of financial assistance, and mentored the students and their parents as well as other members of students' families. The OCCCS expanded the mission of the FIPSE Project by assisting high school students enrolled in Dallas Independent School District high schools in Oak Cliff in preparing for and applying to two-year and four-year colleges and universities, as well as applying for scholarships and financial aid. The OCCCS included students' parents as participants in its programs and activities in an effort to engage them more fully in supporting their children's higher education.

Toward the close of the FIPSE grant, I was instrumental in securing a new, successful FIPSE grant from the U.S. Department of Education developed by administrators and faculty members in the Dallas County Community College District Dr. Gonzalez and I approached and with whom we worked to develop a second grant application. The new grant built upon the FIPSE Project's community and family-based model.
