Course Description

This course serves as an introduction to the study of politics and political institutions in state and local government. It includes the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. The goal is for you to be able to think critically and logically about the functions of local government and how they impact your lives.

 in the US. Current events should be monitored using major newspapers and television
 news sources.

Course Objectives

Upon successful completion of this course, students will:

1. Explain the origin and development of the Texas Constitution.

- 2. Describe state and local political systems and their relationship with the federal government.
- 3. Describe separation of powers and checks and balances in both theory and practice in Texas.
- 4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas government.
- 5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
- 6. Analyze the state and local election process.
- 7. Identify the rights and responsibilities of citizens.
- 8. Analyze issues, policies, and political culture in Texas.

Grading Criteria

Exams

The three exams will be given during class on the dates noted in the course calendar below. Students will need to bring a Scantron form 882-E and pencil. Half of the questions for the exam will come directly from the quizzes, the other half will come from lecture notes, so class attendance is vital to your success. The three exams are open note (NOT open book) and will cover the material from each unit only (not comprehensive).

No makeup exams will be given! The only exception to this rule is absence due to official travel for university business or religious holiday. If you miss an exam for any reason you may take the final exam during the time period assigned by the University. The final exam may only replace one missed exam. If you miss more than one, the others will be graded as 0. The final exam may NOT be taken to raise the grade of another exam. There are no exceptions to this rule. The final exam will be in class (on Scantron), comprehensive, and closed book. Plan your semester accordingly.

Quizzes

Quizzes will be taken via eLearning and are due by 11:59PM on the date listed in the course calendar below. Each quiz will open approximately three days before it is due to provide ample time to complete. Each quiz will also have a two hour time limit once it has been started. Please ensure you plan enough time to complete each quiz.

There are no makeup quizzes. If you miss a quiz it will be graded as a 0. It is important to take the quizzes seriously as half of your exams questions come directly from them. I suggest saving and printing them to review for the exams.

Clicker Questions

Clicker questions will be given in class at random times throughout the semester. Individual questions will be presented during the lecture with a 30 second time limit to respond. Questions may or may not have factual answers, or may be opinion based. Grades for clicker questions will be awarded based on participation, not the answer submitted. Failure to answer a question will result in no score be given for that question.
